### **Litigation Update**

Last summer BCPOA reached a settlement with the homeowners against whom it had appealed adverse decisions on two zoning matters. The terms of the settlement are confidential, but the settlement resulted in dismissing the lawsuit against the homeowners, leaving only BCPOA's claims against Gallatin County.

At this writing, the ink is barely dry on a separate settlement with the County, to be ratified June 5th, in which the County agrees to clarify and revise a number of County administrative procedural rules and portions of the zoning. These include establishing a firm date of any decision by the Planning & Zoning Commission and the County Commissioners, clarification of appeal periods, and clarifying when a matter may be resubmitted after an initial denial. Any changes must be approved by the Planning & Zoning Commission and ultimately by the County Commissioners after a public hearing.

In a separate matter, BCPOA unsuccessfully opposed an application for a Conditional Use Permit for a storage building, but did convince the Planning Department to issue a letter that endorsed BCPOA's position that covenant compliance is independent of zoning compliance and that a resident must comply with both.

# **Zoning Update**

Last June the County Planning & Zoning Commission adopted a Resolution of Intention to Amend the Bridger Canyon Zoning Regulations, the first step to-

ward formal consideration of the new zoning that we will propose for the Bridger Canyon Zoning District.

We have near-final drafts on almost all substantive portions of the new zoning regulations that we will propose. These were summarized in last year's newsletter and the drafts have changed little over the past year. A number of factors have delayed completion of the draft, including. some unexpected comments from the County Planning Department. BCPOA's representatives on the Zoning Advisory Committee are working toward completion, hopefully for presentation to the County this autumn.

### **Next Steps**

When the drafts are presented they will be considered first by the Planning & Zoning Commission and ultimately by the County Commissioners. Both bodies have indicated that before final consideration they would like to have a "working session" at which any member of the public could comment and the Advisory Committee could work with the County to meet concerns expressed by the Commissioners. The County, and BCPOA, will publish advance notice of the working session and any other meetings at which the proposed new regulation will be considered. The notices will include directions on submitting written or oral testimony on the proposed zoning regulation.

BCPOA encourages Canyon residents to participate in this process and to bring to BCPOA's attention any comments you may have. It is easier for us to address concerns if we receive them from you first. You may submit comments to us through [add link] or by communicating with any member of the BCPOA board.

## Code of the Canyon

Under the leadership of former board member John Sackett BCPOA prepared and published a short brochure called The Code of the Canyon. This brochure is intended to supplement Gallatin County's Code of the West and Code of the New West brochures that inform residents and prospective residents of attitudes and customs of which they should be aware. BCPOA's

brochure builds on the County's brochures by identifying matters of special importance in a rural area such as Bridger Canyon. It also describes BCPOA's make-up and activities and encourages new residents to join. We intend to distribute our brochure to local realtors and builders as well as to new residents, and will provide copies on bcpoa.net.

## **Budworm Spraying**

BCPOA hasn't heard of any specific plans for spruce budworm aerial spraying, but we'd like to remind you that safety concerns, and common courtesy, dictate that you let your neighbors know when spraying will occur. See the budworm page on bcpoa.net for details:
